2. The objects of the Trust are :-

b) To encourage teachers, instructors and experts of good moral character and conduct so as to enable to impart efficiently and up to date instruction to pupils in Modern Sciences, intellectual and other useful pursuits and in other subjects as directed and approved by the Central Board of Secondary Education or other authorities.

c)To establish, maintain and run a Boarding House and residential institution for the students and those connected with the institution

d)To invest, dispose of, transfer and otherwise deal with the subject matter of the Trust in such manner as the Trustees should deem fit so as to enable them to carry on the object of the Trust effectively.

e)To accept donations, grants, presents and other offerings and to deal with the same for the purpose of the Trust.

3. The name of the Trust should be "A.M.EDUCATION TRUST".

4.If any vacancy arises in the Board of Trustees on account of death or incapacity, remaining Trustees may co-opt any person who is the legal heir of the Trustees who is dead or incapacitated.

5. The financial year of the Trust shall be the calander year ie, from January 1 $^{\rm 5t}$ to December 31 $^{\rm 5t}$.

6. The Trust is shall neither share the profits nor utilise the Trust fund for any purpose other than the object of the Trust.

7.Any question arising in the administration of the Trust shall be decided by unanimous decision of all the Trustees. If there is an indifference of opinion, the matter should be referred to an arbitrator, whose decision shall be final and is binding upon all Trustees.

8. The Trustees are at liberty to nominate one of the Trustees as Secretary in order to manage the day to day affairs in the administration of the Trust. The Secretary shall submit a full administration of the Irust. The Secretary Shall Submit a Tull and correct account of the acts and deeds done by him in the next meeting of the Board of Trustees and get their approval or ratification. The Trustees may out of the corpus of the Trust property spent such money for laying out, errecting and furnishing any building or for incurring any capital expenditure as may be necessary for realising the object of the Trust. They can also raise additional funds by borrowing or pledging or whatever means as approved by the Board of Trustees.
